  - Specification, Definitions and Approved Materials: Should accessory structures be explained in detail?
  - Should the carport be included in the 50% of the actual structure? What is the percentage for larger lots?
  - Page 8: Remove the word "block" under carports and add "framework".
  - Page 11: Steps remove the word "fiberglass".
  - Page 14: Arbors remove the word "ground", add "structurally" anchored into "concrete". Anchoring specifications must be provided when submitting the permit application.
- 8. Sunshade requirements.
  - Sun sail poles should not exceed the eaves of the home.
- 9. Members to bring up additional items to be discussed.
  - Page 15: Remove the paragraph regarding permits not being submitted prior to work should be removed.
  - Page 15: Section on decorating should be removed.

Discussion of increase the square footage of the prefabricated storage units to either 30 or 36 sq. ft. Mr. Salvemini would like to see the increase due to have a place to store his bicycles.

3. Sizes of garages on joined lots.

Discussion to allow garage on joined lots to equal the square footage of the home.

4. Fencing – access requirements.

Discussion to enforce the fence installations to allow the access to the utility boxes. Mr. Lupien explained his experience in the electrical field. He feels that this is very important as well as access water damage.

5. Addition square foot percentages.

Discussed if the carport square footage should be included when additions are requested.

6. Flagpole requirements.

Discussed that flag poles 20' height requirement. Also only allowing one per property.
