- **Call to Order:** Called to order at 9 am.
- **Pledge of Allegiance:** Led by Chair Tom Nelson.
- **Roll Call:** Chair Tom Nelson, Paul Voit, Hurrol Brinker, Gary Gresko and Alternates Peter Carey and Joseph Klosky, CDO. Vice Chair Melba Lochmandy was excused.
- **Chairperson's Report:** Chair Nelson explained the list sent of items to discuss.
- **Member's and other Reports:** None
- **In Attendance:** Michael Morrissey, BOT Liaison, Rich Armington, General Counsel Cliff Repperger, Resident Relations/HR Manager, and Sally-Ann Biondolillo, DOR/ARCC Administration Assistant.

New Business:

1. Setbacks for swimming pools and screen enclosures

General Counsel Cliff Repperger explained that the setbacks set by the TRZ1 are what needs to be followed. Barefoot Bay has a setback of 7 ½ feet where the County has the setback is 5'.

2. Enclosure of Carports

It is stated in the DOR that there should be unobstructed area of 11' x 18' and Staff feels once the carport is totally screened in and used as a "room" with furniture and things it is no longer a carport. Some of the Committee members feel that if there is an 8' opening it should be allowed. There will need to be another discussion on this topic.

3. County permits attached to Barefoot Bay permit application

The Committee discussed if it could be a requirement that the approved Brevard County permit be attached to the Barefoot Bay permit application. Staff explained that on page 3 of the application the homeowner must initial that they are responsible for applying for a county permit, if needed. General Counsel explained that it would really be if a permit wasn't applied for it really is between the County and the homeowner. That staff has the right to inform the County if a permit should have been issued for certain projects and was not.

4. Survey Stakes

The Committee discussed making a requirement that survey stakes be left in place for lot lines and house placement when a new home is being installed. Staff explained that there really isn't a way to enforce this since the stakes could be knocked down, damaged, or moved.

5. Concrete walkways

The Committee discussed should concrete be allowed to be poured up to the lot lines. There is some concern about water run off into the adjacent lot. General Counsel stated that if that was to happen it would really be a county and/or civil matter.

6. Fiberglass steps

The Committee discussed to prohibit the installation of fiberglass steps to the entrance of any homes. It is stated that the entrance steps must be constructed of concrete.

7. Sizing of Garages

The Committee agreed that a garage can be 100% of the square footage of a single wide home.

8. Placement of Free-Standing structures

The Committee want to discuss the locations and setbacks for free-standing structures. It was agreed that the setbacks in the DOR must be followed. All structures must be anchored.

9. Decorations and Lawn Signs

The Committee agreed that decorations can be placed on any Lot by the homeowners. Staff explained that signs can be placed on the homeowner's property. Signs place in the medians and right of ways is prohibited and can be removed. Election signs are permitted until the election has been held.

10. Work prior to submittal

The Committee discussed having a homeowner that starts work prior to receiving an approved permit must appear and explain why. Staff explained that many of the applications submitted after work has begun have done so because a violation had already been issued.

11. Fees for permits

The Committee discussed the right to charge a fee for permits. General Counsel explained that this would need to be a DOR Amendment not a topic for the Guidelines.

12. Placement of Homes

The Committee discussed the placement of homes on a any lot. Any manufactured or modular homes must be places across the lot line of double lots.

13. Flag Poles

The Committee discussed the flag poles. A permit application with a survey needs to be submitted to show the placement of the flagpole is on the homeowner's property. The maximum height of the flagpole is 20'.

14. Wooden Decks

The Committee discussed that when a deck is constructed, the steps must land onto concrete.

Closing Remarks: The Committee will decide on another date to complete any updates to the Guidelines.
