A RESOLUTION OF THE BOARD OF TRUSTEES OF THE BAREFOOT BAY RECREATION DISTRICT AMENDING THE RULES FOR THE BOARD OF TRUSTEES OF THE BAREFOOT BAY RECREATION DISTRICT; AMENDING ARTICLE III TO CONFORM WITH NEW TERM LIMIT PROVISIONS IN CHARTER; AMENDING ARTICLE VI TO CONFORM WITH NEW EXPENSE AUTHORIZATION IN CHARTER AND POLICY MANUAL; AMENDING ARTICLE X TO REMOVE REQUIREMENT THAT AMENDMENTS TO RULES BE MADE BY RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

*Mr.* Klosky made a motion to approve resolution 2023-03 as read. Second by Ms. Tummolo. Motion passed unanimously.

#### Pool #1 Resurfacing Project - Award of Contract

Consider the three (3) bids received for resurfacing and replacing various components of Pool #1; award a contract, with an alternative contract award to the BOT's second ranked firm, should a contract not be successfully negotiated with the BOT's first ranked firm; and authorize the BOT Chairman to sign the contract.

Mr. Brinker asked if the awarded contractor will be required to adhere to timeline guidelines. Mr. Cichon responded yes, and that the timeframe would be written in the contract. BOT spoke in favor Family Pools as the contractor for the Pool #1 resurfacing project. Mr. Amoss suggested Bob's Pools as the second ranked firm.

*Ms.* Tummolo made a motion to award the contract for the resurfacing and replacing of various components of Pool #1 in the amount of \$67,410.00 to Family Pools, Inc. with an alternative contract award to the second ranked firm, Bob's Pools, should a contract not be successfully negotiated with the BOT's first ranked firm; and authorize the BOT Chairman to sign the contract. Second by Mr. Brinker. Motion passed unanimously.

#### Background and Summary Information

Violation Article III Section 4 (A) (B) (C) (E) - Pets

This case was opened on February 3, 2023 after confirmation from Brevard County Animal Services and Enforcement that this dog was found to be a Dangerous Dog under Section 14-49 of the Code of Ordinances of Brevard County, FL. Found to be in violation by the Violation Committee on February 24, 2023.

Staff recommends that the BOT refer this violation to General Counsel Olsen for legal action, equitable or other appropriate action with failure to comply. If the BOT brings any such action to enforce the DOR, the charge of such action shall be charged to the Respondent's account and shall constitute as a lien.



In the event that the Recreation District determines that the Owner or Occupant of the Lot to whom such notice of violation has been given has not corrected the violation within the time set forth in the notice, the Recreation District may, in its discretion, consider the issue of such violation at a regular meeting of the Board of Trustees of the Recreation District. If the Board of Trustees concurs that legal action is necessary to cause the alleged violation to be corrected, the Recreation District shall thereafter have the authority to bring an action for injunctive or other appropriate relief in a Court of-competent jurisdiction in Brevard County, Florida. If the Recreation District brings such legal action to enforce the provisions of this Instrument, the Recreation District shall be entitled to an award of attorney's fees and court costs incident to such action.

Your case which is set to be heard by the Board of Trustees, may than be forwarded to the District's attorney for legal action at that meeting.
