

Board of Trustees Regular Meeting
October 8, 2021

Meeting Called to Order

The Barefoot Bay Recreation District Board of Trustees held a Meeting on October 8, 2021, Building D&E 1225 Barefoot Boulevard, Barefoot Bay, Florida. Mr. Maino called the meeting to order at 1PM.

Pledge of Allegiance to the Flag

Led by Mr. Maino.

Roll Call

Present: Mr. Grunow, Mr. Nugent, Mr. Morrissey, Mr. Amoss, Mr. Maino. Also, present, John W. Coffey, ICMA-CM, Community Manager, Cliff Repperger, General Counsel, Stephanie Brown, District Clerk, Matt Goetz, Property Services, and Rich Armington, Resident Relations, Ernie Cruz, Golf Operations Manager and Kathy Mendes, Food & Beverage Manager.

Additions or Deletions to the Agenda

Mr. Nugent requested item 11D overseeding the Golf Course be added to the agenda.

Mr. Maino requested item 11E BBRD General Counsel Letter of Resignation be added to the agenda.

Approval of the Agenda

Mr. Nugent made a motion to approve items 11D and 11E as additions to the agenda. Second by Mr. Grunow. Motion passed unanimously.

Presentations and Proclamations

Cancer Awareness Proclamation was presented to the CVO by Chairman Maino.

Approval of Minutes

Mr. Amoss made a motion to approve minutes dated September 28, 2021. Second by Mr. Morrissey. Motion passed unanimously.

Treasurer's Report

Mr. Grunow made a motion to approve the Treasurer's Report for October 8, 2021, as read. Second by Mr. Amos. Motion passed unanimously.



Audience Participation

Jeanne Osborne-100 Cherokee Court-expressed her concern about General Counsel Repperger resigning and spoke in favor of Mr. Repperger rescinding his resignation.

Unfinished Business

Discussion of COVID-19 Precautions

Mr. Coffey explained Mr. Cruz's recommendation to cease the temporary 1 rider per golf cart rule on the Golf Course. Mr. Nugent spoke in favor of no new restrictions at this time. Mr. Maino spoke in favor of keeping the rule in place through October. Mr. Cruz stated that on certain days more cart usage is exerted.

Mr. Nugent made a motion to extend the one-rider per golf cart rule for the Golf Course until October 29, 2021, and reevaluate the temporary rule at the October 26, 2021, BOT meeting. Second by Mr. Grunow. Motion passed unanimously.

Steward Medical Group Proposed Ground Lease

Approve Commercial Ground Lease with Steward Medical Group.

Mr. Nugent made a motion to approve Commercial Ground Lease with Steward Medical Group. Second by Mr. Morrissey.

Mr. Nugent amended the motion to approve the Commercial Ground Lease with Steward Medical Group to include exhibit B as presented. Second by Mr. Morrissey. Motion passed unanimously.

New Business

Violations Committee Appointments

Selection of two homeowners to fill vacant positions and re-appointment of all current members to 3-year terms.

Mr. Grunow made a motion to appoint Hurrol Brinker, David Wheaton, Vickie Sloss, John Vogt, and Stephen Holmberg to voting members and Sue Hall and Louise Crouse as alternates for 3-year terms effective October 1, 2021. Second by Mr. Nugent. Motion passed unanimously.



Golf Course Lake Bank RFP Evaluation Committee Recommendation

Staff recommends the BOT award contract for Golf Course Lake bank restoration to Crosscreek Environmental, Inc. in the amount of \$237,276.00, authorize Chairman Maino to sign the contract when available.

Mr. Maino asked what the extra \$51,000 cost covers (initial bid was \$186,186.00). Mr. Cruz responded that it covers all lake banks left of #1, right of #1 and left of #11.

Mr. Nugent made a motion to award contract for Golf Course Lake bank restoration to Crosscreek Environmental, Inc. in the amount of \$237,276.00, and authorized Chairman Maino to sign the contract when available. Second by Mr. Grunow. Motion passed unanimously.

Neighborhood Revitalization Program (NRP) Purchase Confirmation 413 Plover Drive

Staff recommend that the BOT confirm the purchase of 413 Plover Drive via the Neighborhood Revitalization Program.

Mr. Amoss made a motion to confirm the purchase of 413 Plover Drive via the Neighborhood Revitalization Program. Second by Mr. Morrissey. Motion passed unanimously.

Golf Course Overseeding

Mr. Nugent spoke in favor of having a system to replace the Bermuda grass due to overseeding. He asked if overseeding is postponed, when would be the deadline to overseed. Mr. Siler responded no later than mid-December.

Brad Seiler-District Manager with ABM-explained why greens should be overseeded (size, drainage).

Mr. Maino requested a report from Mr. Cruz/Seiler detailing the pros and cons of overseeding. Mr. Siler responded that he could create a report.

BOT consensus to revisit this issue at the November 12, 2021, BOT Meeting.

BBRD General Counsel Letter of Resignation

Mr. Maino read the resignation letter sent by General Counsel Repperger. Mr. Repperger gave an explanation for his resignation and stated that the decision is not a negative reflection of the BOT or BBRD Staff.

Mr. Morrissey made a motion to accept General Counsel Repperger's resignation. Second by Mr. Grunow. Motion passed unanimously.

Mr. Coffey presented proposed new general counsel recruitment process. Mr. Repperger stated that process/timelines were ok, and the timeframe was sufficient. Mr. Grunow spoke in favor of moving forward with the timeline.
