FY24 Proposed Budget Mailout

Mr. Grunow made a motion to waive the requirement of Section 2.8 of the BBRD Policy Manual, which stipulates that on or before the Monday after the May meeting the proposed budget, proposed assessment rate, and prior year financial statements be mailed to all property owners of record, and require that the proposed budget, proposed assessment rate, and prior year financial statements be mailed at a minimum of fifteen (15) days prior to the June 27, 2023, public hearing to adopt the BBRD FY24 Budget, and that this waiver shall only apply to the FY24 Budget development and approval process. Second by Mr. Klosky. Motion passed unanimously.
