# Community Manager's FY23 Budget Review Update

While the Trustees discussed priorities and heard from the public at the last Budget Workshop, the consensus was to defer final decisions till the May 3rd and 5th workshops after the Employee Pay and Benefits Report is received (anticipated in late April). Staff received preliminary information from the outside consultant last week indicating the BBRD Pay and Classification Plan is approximately 20% below average for similar/competing organizations. Given the cap on increasing assessments, 5 more years of \$1/hour minimum wage increases, and 40-year record high inflation, the current and future BOTs will have increasing difficult decisions in developing budgets. While the BOT has approximately \$238,000 in the FY23 Proposed Budget to address employee wages (combination of normal annual increase, state minimum wage increases, and money to address compression of the pay plan), double that amount is actually needed right now to get BBRD to an average pay plan when compared to other employers.

If that amount of money seems large to you, please remember that BBRD's salaries and wages total \$2.5 Million for the 125 employees who work here. And if you think the one-time social membership revenue gives BBRD a lot of money, while the \$630,000 in receipts next year is sizable, it is less than 10% of the total budget of \$7.4 Million.
