# **How does BBRD operate?**

BBRD operates under the "Council-Manager" form of local governance (most common form of local government in the USA). The BOT adopts the budget, approves certain purchases, sets policies, and other administrative procedural documents (i.e. Employee Handbook, Food & Beverage Principles of Operations, etc.). The BOT has only two employees: the Community Manager and General Counsel. All other employees and vendors work through an established chain of command (Supervisors to Department Managers to the Community Manager). Although the Community Manager is a contracted position with Special District Services, Inc. (SDS), the role of SDS is primarily an oversight and resource of information for the Community Manager and does not play a daily role in operational decision making.

All personnel decisions (except for the two employees of the BOT) are handled by staff under the rules and procedures of federal and state law, Employee Handbook rules, and the principles of fairness and equity. Trustees are supposed to have no role in personnel decisions. Although I cannot speak to how things were done prior to my arrival in October 2013, some people still have the misperception that employment decisions are based on popularity and if enough people complain about a specific employee that person will be fired regardless of his/her performance.

Regarding daily operations, BBRD operates like any other local government. Staff follows procurement rules in seeking quotes/bids. Although some people think our staff should be a governmental concierge (i.e. help them with services provided by Brevard County, the State of Florida, the Federal government, etc.), the focus of our staff's time is BBRD amenities, services, and facilities maintenance. The staff does coordinate with other governmental agencies when in the best interest of the public, but BBRD does this as a courtesy and not because staff is responsible for services such as law enforcement, County code enforcement, roads, utilities, etc.

Many people think of BBRD as "not a real government" agency. This is simply not true. "Homerule" governments can do anything that is not expressly prohibited by Florida Statutes. However, BBRD cannot start providing a service or imposing a tax/fee not already enumerated in Florida Statutes for Special Districts (i.e. law enforcement, fire protection, etc.). Hence, that is why BBRD only provides recreational services and maintenance of common areas.
